**RESIGNATION OF NON-EXECUTIVE DIRECTOR AND

**Appointment of Vice President**

The Board announces that Mr. Hong Jie has been appointed as Vice President of the Company with effect from 3 September 2009. Mr. Hong Jie, aged 41, joined China Resources (Holdings) Company Limited (the immediate controlling shareholder of the Company) in 1992. He became the Assistant General Manager and then the Deputy General Manager of the Finance Department of China Resources (Holdings) Company Limited during the period from 1999 to 2003. He became the Chief Financial Officer of China Resources Vanguard Company Limited (“CRVCL”) in April 2003, the Chief

Operating Officer of CRVCL during the period from June 2006 to May 2009, and the Chief Executive Officer of CRVCL in June 2009. He holds a Bachelor's degree in Economics from the Hangzhou University of Commerce (now known as Zhejiang Gongshang University).

Save as disclosed above, the Board is not aware of any other matters with respect to the resignation of Mr. Wang Shuaiting that are required to be disclosed or brought to the attention of the shareholders of the Company pursuant to Rule 13.51(2) of The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.
